Dear Sir/Madam:

I represent Mr. William Devitt in connection with the above-captioned lawsuit. As reflected in the federal lawsuit filed on December 16, 2024, Mr. Devitt is seeking the immediate of his 17.8 Bitcoin, or the equivalent value in USD as of the date of the filing of the complaint. Your continued refusal to provide Mr. Devitt access to his funds is unlawful as alleged in the complaint.

I also hereby tender Mr. Devitt's claim for attorneys' fees under Tex. Pract. & Rem. Code § 38.0002 *et seq.* and pursuant to the DTPA under Tex. Bus. & Com. Code §§ 17.50(c) and pursuant to the TTLA under Tex. Civ. Prac. & Rem. Code § 134.005(b). My fees on this matter accrue at the hourly rate of \$1350. Mr. Devitt's claim for damages from your unlawful retention of his assets is also subject to his claim to pre-and post-judgment interest.

If you desire to settle the lawsuit, please contact me at your earliest convenience.
